ELIGIBILITY: The Goldman Sachs India Hackathon is a skills based competition (the "**Contest**") open only to students eighteen (18) years of age or older who are enrolled in engineering courses in either their sophomore, prefinal or final year at a school listed in <u>Schedule A</u>, which is incorporated herein by this reference (the "**Eligible Schools**"). The Contest is not open to employees, officers or directors, or to members of the immediate family or household (whether related or not) of any employees, officers, or directors of Goldman Sachs Services Pvt. Ltd. ("**Sponsor**"), or any of its parents, subsidiaries, affiliates, franchisees, or any advertising, promotion or other agencies or suppliers involved in this Contest (collectively, the "**Contest Entities**"). Limit one (1) entry per person per HackerRank account throughout the Contest Period. Entrants suspected of using macro, script or other forms of automatic entry and entries that subvert the entry process (within the sole determination of Sponsor) may be disqualified at Sponsor's discretion.
